(e) That pending the hearing and final disposal of the suit, the Defendant No. 1 Officers and servants be restrained by an Order of injunction of the Hon'ble Court from taking any further action pursuant to impugned notice dated 18th October, 2014 and Notice dated 24/10/2014 being Exhibit "T" Collectively in Plaintiff's respect of the suit premises No. 3 of Plot No. 29A, C.T.S. No. 1265 of Vill. Mulund (W), Taluka Kuria, Mumbai Suburban District.

(f) That pending the hearing and final disposal of the suit, the Defendant No. 1 is ordered and directed to take measurement of the suit premises from legal Metrology Department, BMC and to inform the Plaintiff in writing of the same.

(g) That pending the hearing and final disposal of the suit, the Defendant No. 1 is ordered and directed to take measurement of the suit premises from legal Metrology Department, BMC and to inform the Plaintiff in writing of the same.

(h) That pending the hearing and final disposal of the suit, the Defendant No. 1 is ordered and directed to take measurement of the suit premises from legal Metrology Department, BMC and to inform the Plaintiff in writing of the same.
